Purpose:

This report is hereby submitted by Joule Assets, Inc. ("Joule") on behalf of applicable municipalities in New York State in accordance with annual reporting requirements established in New York Public Service Commission "Order Authorizing Framework for Community Choice Aggregation Opt-Out Program" (effective April 21, 2016) and "Order Approving Joule Assets' Community Choice Aggregation Program with Modifications" (effective March 16, 2018) in Case #14-M-0224.

In 2021, Joule served as Community Choice Aggregation (CCA) Administrator for active Programs in 24 municipalities, 11 in Central Hudson territory, 6 in Orange & Rockland territory, and 1 in New York State Electric & Gas territory, 4 in Rochester Gas and Electric territory, and 2 in National Grid Service Territory. 17 municipalities were in operation at the beginning of 2021, and 7 municipalities began their programs during the year. 1 municipality left the program during the year.

Community Choice Aggregation Reporting

In 2021 Joule served communities in a total of five utility service territories. NYSEG and National Grid service territories contains Joule's Finger Lakes Community Choice aggregation. Central Hudson service territory contains Joule's Hudson Valley Community Power aggregation. Orange & Rockland service territory contains Joule's Rockland Community Power aggregation. Rochester Gas and Electric service territory contains Joule's Monroe Community Power, Gateway Community Power, and Rochester Community Power Aggregations.

Annual reporting information for the year 2021 was impacted for Central Hudson municipalities as a consequence of Central Hudson's transition to a new customer information system. This new system caused a litany of errors that have impacted information transfer to both customers and ESCOs, including the ESCO for the Hudson Valley Community Power CCA, Columbia Utilities (Indra Energy). This has impaired Joule's access to accurate information on the customers being served from August of 2021 to December 2021, the period of 2021 effected by these technology issues. The information in this report for these months is a combination of limited data provided by Columbia, and estimates based on past usage and historical trends. Joule will provide an update with revised numbers once the Central Hudson issues have been resolved.

Joule conducted customer refreshes in most participating municipalities at various points throughout 2021. Customer refreshes ensure that customers who have newly moved into the municipality and become eligible for the program are given the opportunity to take advantage of CCA program rates and the renewable energy offering. The refresh schedule for 2021was as follows:

Orange and Rockland

• All municipalities in April of 2021

Rochester Gas and Electric

• Brighton, Victor, and Canandaigua in April of 2021

Central Hudson:

• None; contract renewal in July of 2021

National Grid

• None; contract start date in September 2021

NYSEG

• None; contract renewal in July of 2021





<u>4. Comparisons between utility supply price and CCA contract price:</u>


The participating municipalities are covered by contracts with three different electricity suppliers. Eleven of the participating municipalities in Central Hudson and NYSEG territory are receiving energy from Indra Energy (Columbia Utilities), for fixed rate contracts with two supply options: Standard (grid mix), and 100% Renewable (New York State Environmental Disclosure Program Compliant). Ten of the participating municipalities in Orange & Rockland, NYSEG, National Grid, and RG&E service territories are receiving energy from Constellation, for fixed rate contracts with two supply options: Standard and 100% Renewable. Three of the participating municipalities are receiving electricity supply from Icon Energy, for fixed rate contracts with one supply option: 100% Renewable.








7. CCA Administrative Costs Collected:

Joule collects administrative fees at a rate of \$0.0008/kWh on the energy it supplies to its CCA programs. Administrative fees are collected from all program suppliers, Columbia, Source Power, and Constellation, for their respective supply.

Joule evenly shares its CCA Administrative fees with Local Organizers that oversee local operations for Joule's member municipalities. Fees are dispersed to Roctricity, who covers municipalities in NYSEG, RG&E, and National Grid territories, and Hudson Valley Energy who covers municipalities in Central Hudson and ORU service territories.

All fees collected have contributed to core Program operational costs (i.e. staff salaries, facility and equipment expenses, travel and meetings expenses, and production of Program materials).

8. Plans for Renewal:

Joule Assets currently serves as CCA administrator for 6 municipalities whose electricity supply contracts are set to expire in November of 2022. All 6 of these municipalities are part of Joule's Rockland Community Power Aggregation. With contracts expiring in November, Joule has initiated a process to secure a new electricity contract for these municipalities. The Village of South Nyack will be dissolving into Orangetown, customer's previously with a contract through South Nyack will be served through a contract with Orangetown.

Rockland Community Power currently offers two fixed-rate electric supply options for participating customers supplied by Constellation. The default for 5 of the 6 communities is 100% New York State Renewable electricity. This reflects the desire of participating municipalities to supply their communities with 100% renewable energy sourced from New York State. One community has the standard grid mix as their default energy supply.

If customers do not want 100% renewable power, but still want to participate in the CCA program, they can choose the Standard supply option. Standard supply complies with New York State requirements for minimum renewable energy content, and closely mirrors the grid mix offered by the utility to basic supply customers. Standard supply is sourced predominantly from natural gas and nuclear generation, with roughly 15% renewable generation (mostly hydro).

Joule seeks to offer similar options when municipalities renew their contracts. Joule will solicit various options for default supply including bids for 100% renewable power with a standard fixed rate as an alternative option. Additional consideration will be given to price and term length to secure optimal rates for member municipalities.

9. Additional Information, Website Activity:

As a method of showing CCA customer engagement, Joule is including metrics on its websites.
